

"Intuitive Blooms LLC" reserves the right to cancel this contract if at any time we feel that the obligations cannot be met. In the event of fire, natural disaster, tragedy, or other emergency, liability is limited to full refund of all monies paid. Retainer fee is non-refundable.

Terms: Deposit of 35% is due at signing of contract. Payments may be in cash, check, money order or by credit card (Visa, Master Card, Discover or American Express). Any checks deemed Insufficient Funds are subject to a \$35.00 return check fee and will no longer be accepted.

As part of this agreement, customer will receive a detailed invoice of services and products rendered, as well as a concept sketch of said designs. The conceptual sketch/design can be altered at any time, but will require approval and signature of customer before product is ordered and physical designing of product begins.

Balance due must be paid in full 14 days prior to the wedding date. If payment is not made in full, flowers will not be ordered and this agreement is no longer valid.

Additional purchases will be invoiced at the time of order. If ordered after your final payment, they must be paid prior to delivery. Additions will be accepted up to two days prior to wedding date. No guarantee is given that the same flowers will be available on orders made less than two weeks prior to wedding. Color and style will be matched as close as possible.

Cancellations: We understand this is a custom order and understand if payment is not made in full, this contract is canceled and all payments are forfeited. Contract cancellation should be made in writing. There are no refunds for cancellations of individual items after contract is signed. Flowers for those items will be utilized to upgrade the arrangements purchased. Cancellations made less than 2 weeks before the wedding date may forfeit full payment if "Intuitive Blooms LLC" has ordered flowers and the order cannot be cancelled.

Substitutions: We reserve the right to make substitutions in the event the flowers received are not of the quality suitable for your wedding. In this event, the integrity of the proposed color scheme will be maintained and flowers of equivalent value will be used.

Delivery: "Intuitive Blooms" cannot be held responsible for the care of flowers made after delivery or exchange of hands with product.

Rental: All rental items must be returned to "Intuitive Blooms LLC." Any rental items not returned will incur an additional fee. Items must be returned in like new condition; vases cleaned, wax removed from votive holders, no chips, cracks or breaks to any rental item. If items are returned in poor condition, customer will be held financially responsible for replacement of said items. Rentals are due back to "Intuitive Blooms LLC" within 1 week of wedding date or additional rental fees may incur.
